Mr. Guise stated that Penn Forestry has placed a "Request for Bids" on the trees to be harvested from GMA's property located in Cumberland Township. Bids will be opened publicly at 1:00 P.M. on Thursday, August 31, 2017 at the Penn Forestry Company. Mr. Guise will report the results of the bidding at the next Board of Directors meeting.

CAJCP - Comprehensive Plan Draft-suggested text updates:

Mr. Guise presented the Board with the suggested changes from the County in response to GMA's recommendations from July 13, 2017 e-mail and their subsequent meeting discussion.
